Trevor Conway commented, "Dubai has positioned itself as a financial service center for the region and has a very pro-business environment. Since we broker both over-the-counter (OTC) physical and derivative products, Dubai was an obvious choice for our first TFS office in the Middle East." Trevor continued, "Other driving factors in our decision were the opening of the Dubai Gold Exchange in late-2005, the imminent launch of the Dubai Mercantile Exchange, and the fact that Dubai is the largest physical purchaser of gold on the subcontinent (India, Pakistan and the Middle East)."

TFS is located in the Dubai International Finance Centre (DIFC), which houses the Dubai International Finance Exchange (DIFX), and is regulated to international standards by the Dubai Financial Services Authority (DFSA).
